# ParishSOFT Family Suite

## Resolved Issues

---

### System-Wide

#### Fixed: Web-Based Email Users Experiencing Recipient already specified Error

Previously if the same email address was used among the To, CC, and Bcc fields, users of web-based email experienced an error like the following:

```
Bad sequence of commands...Recipient already specified
```

We fixed this issue. Users of web-based email can now successfully send email even if an email address is duplicated among these fields.

#### Fixed: Users Experiencing Unexpected Timeouts of Mail Merge Sessions

Previously when using Mail Merge, some users experienced unexpected timeouts. We fixed this issue.

### Family Directory

#### Fixed: Users Experience an OOps Error After Responding 'Yes' to Message Prompt

Previously, users experienced an OOps error after responding **Yes** to the message prompting them to confirm whether they also want to make all members of a family either active or inactive. We fixed this issue.

### Religious Education

#### Fixed: 'Add By Family' Process Sometimes Removes Target Grade When Moving Students

Previously when a user used the **Add By Family** process to move a student from one class to another, the system sometimes removed the grade the student was being moved to. We fixed this issue.

#### Fixed: 'Parents Only' and 'Birthdays Only' Data Options for Students Generate No Data

Previously, reports that had the **Parents Only** and **Birthdays Only** data options selected for students generated no data. We fixed this issue.

## Offering

### Fixed: Contribution Postings Report Sometimes Contains No Contribution Data

Previously when users generated a Contributions Posting report for a family workgroup, the report output sometimes contained no contribution data for families in the selected workgroup. We fixed this issue.

### Fixed: Users Sometimes Experience an OOps Error When Exporting a Fund Summary Report

Previously when users selected the **Fund Summary** option in the setup for the Contribution Postings report and then tried to export the summary file, they experienced an OOps error. We fixed this issue.

## IQ

### Fixed: Users Not Able to Create Family Workgroups from Query Result Set

Previously, users were not able to create a family workgroup from the results of a query that ran successfully. We fixed this issue.

### Fixed: Count Function Applied to Attendance Status Column Produces Incorrect Results

Previously, queries of attendance counts produced results that did not match the attendance counts displayed in the Religious Education application. We resolved this discrepancy.

## Administration

### Fixed: 'Reviewed By' Dropdown List in the Suspense History's Advanced Filter Not Working

Previously, the **Reviewed By** dropdown list in the **Advanced Filter** for Suspense History stopped working. As a result, users could not filter **Suspense History** records to see those reviewed by a selected staff member. The **Reviewed By** dropdown list is now working as expected.

### Fixed: Cannot Create Event Category Lookups with Descriptions Longer Than 25 Characters

Previously, users experienced an error when attempting to save Event Category lookups that had descriptions longer than 25 characters. We fixed this issue. The maximum length of Event Category descriptions remains set to 25 characters. Like all other lookup descriptions, Event Category descriptions longer than the 25 characters are now saved and truncated to the maximum length.

### Fixed: System Blocks Creation of Same-Named Event Lookups in Different Event Categories

We resolved an issue that prevented users from being able to add event lookups with the same name to different event categories. Users can now add same-named event lookups to different event categories without experiencing an error.

### [Notification Message Pertaining to Records Submitted to Overnight Queue Revised for Clarity](#)

For clarity, the notification message displayed to users informing them that selected families will be merged overnight was revised. The reworded message now reads as follows:

The families you selected to merge will be merged overnight. You can view your pending merges in the Merge Family Queue

## Resolved Issues

---

### Census

#### [Fixed: Users Sometimes Not Able to Change the Organization on Workgroups Pages](#)

Previously when the diocese was selected as the active organization, users could not change organizations on both the **Family Workgroups** and **Member Workgroups** pages. We fixed this issue. Users can now successfully select a different organization in the dropdown lists on these pages.

### Administration

#### [Fixed: Merge Process Fails If Duplicate Family Contains a Religious Education Leader](#)

Previously, the family merge process failed if a member in the duplicate family was a Religious Education leader. We fixed this issue. The system can now successfully merge records of members who are Religious Education leaders.

#### [Fixed: Merge Process Cannot Merge Members with ParishSOFT Accounting Access](#)


Previously, the family merge process stalled if a member in the duplicate family had login access to ParishSOFT Accounting. We resolved this issue. The merge process now runs successfully and links the merged member's ParishSOFT Accounting login credentials to the new master record.

#### [Fixed: Merge Process Cannot Merge Records of Online Registrants for Religious Ed Classes](#)

We resolved an issue that caused the merge process to fail if a member in the duplicate family had registered for a Religious Education class using the online registration tool.
